

This award, BYU's most prestigious faculty award, is provided through the generosity of the Karl G. Maeser Scholarship Society. The recipient must have demonstrated clear superiority in both scholarship and teaching.

David B. Magleby

POLITICAL SCIENCE



David B. Magleby excels in scholarship, teaching, and administrative service. His scholarship centers on direct democracy, voter partisanship, and campaign finance. He has published more than a dozen books and edited volumes as well as 89 peer-reviewed journal articles and book chapters. David was a Fulbright scholar and a congressional fellow of the American Political Science Association. He is a recipient of the BYU Sponsored Research Achievement Award and the BYU Maeser Distinguished Teaching Award and was the CASE/Carnegie Foundation Professor of the Year for Utah. David's research has been cited by Supreme Court justices, and he was appointed to a U.S. Senate advisory committee. He is the lead author of a widely used introductory American politics text, Government by the People, now in its 25th edition.

In 1982, in partnership with the BYU Statistics and Communications Departments and other Utah colleges and universities, David established the KBYU-Utah Colleges Exit Poll. The survey, now in its 32nd year, involves hundreds of students each election year. David served 10 years as dean of the College of Family, Home, and Social Sciences; six years as chair of the Political Science Department; and as the founding director of the Center for the Study of Elections and Democracy. He has also been national president of Pi Sigma Alpha, the political science honor society.

David B. Magleby will deliver the 2014 Maeser Distinguished Faculty Lecture at a university forum assembly. The date and time are to be announced.

Ben E. Lewis Management Award

This award recognizes an administrative employee for outstanding management abilities.

Paul H. Bringhurst STUDENT AUXILIARY SERVICES

This award recognizes staff and administrative personnel for exceptional service, creativity, and competence.







This award encourages and acknowledges senior faculty who are outstanding scholars, teachers, and university citizens. It may specifically recognize excellence in scholarship and creative work or reward superior classroom teaching.

Robert T. Barrett VISUAL ARTS



Robert T. Barrett is an accomplished painter and illustrator with national and international solo exhibitions. He received the Society of Illustrators Distinguished Educator in the Arts Award and the Phi Kappa Phi Artist Award and was selected as one of the Most Honored Living Artists of Utah. Barrett has served as an associate chair, chair, and associate dean at BYU and twice as a bishop. He has contributed several hundred illustrations to Church publications, and his work is featured in LDS temples and visitors centers. Notable books he has illustrated include Michelle Obama: First Mom and Christmas from Heaven: The True Story of the Berlin Candy Bomber. Barrett's university textbook, Life Drawing: How to Portray the Figure with Accuracy and Expression, has been translated into several languages.

CENTER FOR ANIMATION





He has mentored many PhD, master's, and undergraduate students in researching significant and widespread pregnancy-related diseases. His scholarship informs his teaching and provides relevant examples of the importance of understanding biochemistry. Steven is an excellent example of a caring teacher whose contributions affect both students and colleagues. He is fully committed to the mission of Brigham Young University.

Larry J. Nelson SCHOOL OF FAMILY LIFE



Larry J. Nelson has displayed a deep commitment to education over the course of his career. He has a gift for teaching, and his engaging classes are among the most popular offered in the School of Family Life. Larry is a passionate and approachable teacher who masterfully integrates gospel principles, personal experiences, and humor into his courses. His student evaluations are consistently exceptional and regularly demonstrate that his classes are not only educational but life changing. Outside the classroom he continues to mentor students, train teaching assistants, and collaborate with undergraduate and graduate research assistants. He is a distinguished scholar with over 70 peer-reviewed research articles and book chapters, many of which are coauthored with students.

Karl G. Maeser Research and Creative Arts Award

Byron J. Adams BIOLOGY



Byron J. Adams is the project director for the International Antarctic Terrestrial Observation Network, a consortium studying ecosystem dynamics and responses to climate warming in Antarctica. He has maintained continuous National Science Foundation support since 2002 with over \$8.4 million dollars in federal funding. He publishes in top-tier journals, including the Proceedings of the National Academy of Sciences, and serves as president-elect for the American Society of Nematologists, which reflects the respect his peers have for his research program. Byron has advised over 100 undergraduates on mentored research projects, and 36 of his 84 peerreviewed scientific papers include BYU student coauthors. Byron's record of scholarship serves as an outstanding example to all BYU faculty.

Adam T. Woolley

CHEMISTRY AND BIOCHEMISTRY



Adam T. Woolley has made distinguished internationally recognized contributions in scholarship; moreover, he excels in teaching and citizenship. His scholarship focuses on the use of miniaturized platforms that can detect and quantify small amounts of biologically significant molecules (referred to as a "lab on a chip"). He has published more than 100 scientific papers, has been awarded more than \$3.5 million of external research support, and has received several external awards for his scientific contributions, including the prestigious Presidential Early Career Award in Science. Adam is an engaging and creative instructor in the classroom and in the laboratory. In addition to his outstanding scholarship and excellent teaching, he is a strong citizen who has accepted numerous and challenging committee assignments inside and outside of BYU. He is an outstanding faculty member in all areas of responsibility.

Karl G. Maeser Professional Faculty Excellence Award

This award recognizes outstanding achievement in fulfilling professional faculty responsibilities and is made possible by the generosity of the Karl G. Maeser Scholarship Society.

Michael D. Brown

PHYSIOLOGY AND DEVELOPMENTAL BIOLOGY



Michael D. Brown is an associate teaching professor in physiology and developmental biology. He currently serves as director of the BYU Neuroscience Center and teaches classes in anatomy, physiology, and neuroscience at various levels of instruction. His outstanding achievement in fulfilling his professional faculty responsibilities in instruction are noted by students, faculty, and staff. Former students have commented: "Superb professor. Gayle G. Lockwood SCHOOL OF MUSIC



Since 1984 Gayle G. Lockwood has been a consummate voice teacher in the BYU Music Dance Theatre program. She has garnered remarkable success, as evidenced by the number of her former students who are now working in national touring companies, on Broadway, and as recording artists. Using a myriad of techniques, she helps students think, learn, and feel encouraged while challenging them to improve. Her passion for learning and discovery and her creativity and imagination are integral to her students' education; her insight and experience prepare students for success in a highly competitive industry. Gayle's attention to detail has been evident in the scores of musicals that have been presented at BYU, and in 2008 she received the coveted Kennedy Center American College Theater Festival award for her musical direction of Little Women.

Chad F. Emmett

GEOGRAPHY



Chad F. Emmett has been a faculty member and general education professor in the Department of Geography for over 20 years. He has taught multiple GE classes including large sections (270 students in some semesters)-and mentored many students. He is a dynamic teacher who upholds rigorous academic standards in the GE curriculum, and his ability to teach and discuss difficult topics in effective ways and to have students join in discussing these topics is impressive. Because of his teaching ability, Chad's students tend to rave about him and his teaching style, and many of them keep in touch with him and regularly express thanks for his classes.

Abraham O. Smoot Citizenship Award

Merrill J. Christensen

NUTRITION, DIETETICS, AND FOOD SCIENCE



Merrill J. Christensen is a nutritional science professor who has given 32 years of service to BYU. He has willingly taught as many as 20 credit hours per year, enlightening students both academically and spiritually. He regularly mentors students every year while exploring the relationship between selenium and prostate cancer. As a leader in BYU's Cancer Research Center, he has successfully secured prestigious National Institute of Health (NIH) funding, and, as an NIH grant reviewer, he willingly shares his grant-writing skills with younger colleagues and others across the nation. Merrill has guided nutritional science undergraduates for more than 15 years as an academic advisor. Throughout his career he has impacted countless students and faculty while serving in numerous capacities across campus and contributing to the broader needs of the university.

Wesley P. Lloyd Award for Distinction in Graduate Education

This award pays tribute to a faculty member of exemplary performance in teaching, research/creative work, and citizenship in graduate education.

Barry M. Willardson

CHEMISTRY AND BIOCHEMISTRY



Barry M. Willardson has made significant contributions to BYU graduate education. An avid researcher with an international reputation, his scholarship into how cells "signal" (i.e., "see" their outside world and convey what they see into actions) provides fundamental understanding of complex biochemical processes. He involves both undergraduate and graduate students in his scholarship, and they are coauthors on his research papers. Setting high standards for education, he is an important role model who demonstrates hard work, scientific curiosity, and a love for the gospel. He teaches his students scientific ethics and meets with them regularly to encourage their progress. Barry is not only an excellent professor but also a team player who is willing to sacrifice his time and efforts to help students and build the department and the university.

Phi Kappa Phi Award

This award is presented to a faculty member who has achieved excellence in scholarly and creative endeavors, exemplifies integrity, and has contributed to BYU through citizenship and service.

Randy S. Lewis

CHEMICAL ENGINEERING



Randy S. Lewis is a professor in the Department of Chemical Engineering and currently serves as department chair. He has been instrumental in dealing with a 40 percent increase in the number of undergraduate students in the department. A champion of humanitarian service learning in his department and college, he helps students perform engineering service projects in Tonga, Peru, and Ghana. He has served on several national committees in the American Institute of Chemical Engineers and currently serves as chair of the Education and Accreditation Committee. He is currently a commissioner for the Engineering Accreditation Commission of the Accreditation Board for Engineering and Technology. Randy's research area of biofermentation for liquid chemicals from nonfood crop biomass is of national interest.

Adjunct Faculty Excellence Award

This award recognizes the contributions of parttime faculty who have demonstrated excellence in teaching or in other professional responsibilities over a period of at least five years.

Susan W. Griffith

LAW SCHOOL



For 20 years Susan W. Griffith has taught law students core professional skills and has provided them opportunities to perform pro bono legal work with a variety of community organizations-Utah Legal Services, the Center for Women and Children in Crisis, the Food and Care Coalition, juvenile justice centers, and senior citizen centers. She has also played an integral role in the Law School's externship program, which is one of the largest in the country, with placements all over the world. Since her graduation from law school, Susan has eschewed financial rewards in favor of helping those who cannot afford legal services. Her example of serving "the least of these" has been as powerful of a teacher to students as her high-quality professional-skills instruction in the classroom.


